IV. Resignation of Mrs. Krystal Hobeiche from the Corporate Board as of July 13, 2026

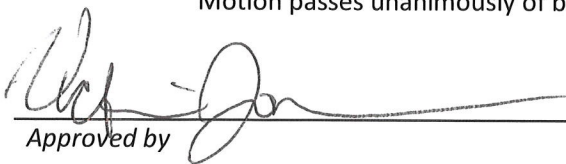
Mrs. Jones informed the board of the resignation of Mrs. Hobeiche and thanked her for her service to the board.
